Submission Guidelines

Abstract Submission

Abstract Format

- Length: The abstract should not exceed 300 words.
- Content: It should briefly state the purpose of the research, methodology, principal findings, and major conclusions.
- Keywords: Include 3-5 keywords at the end of the abstract.
- Format: Use Times New Roman, 12-point font, single spacing, and standard margins.
- Citation Style: Follow the APA 7 citation style.
- References: Include full titles of journals and provide DOI where available.

Full Paper Submission

- Paper Format
- Length: The full paper should be between 4,000 to 6,000 words.
- Structure:
- The paper should include the following sections:

Title, Abstract, Keywords, Introduction, Literature Review, Methodology, Results, Discussion, Conclusion and References.

- Format: Follow the APA 7 style for citations and references.
- Formatting: Use Times New Roman, 12-point font, double spacing, and 1-inch margins on all sides.
- Figures and Tables: Ensure all figures and tables are clear and properly labelled. Include them within the text at the appropriate places.
- Citation Style: Follow the APA 7 citation style.
- References: Include full titles of journals and provide DOI where available.

Submission Process

- Online Submission: Submit your full paper through the conference's online submission system.
- Deadline: The full paper must be submitted by the specified deadline.
- File Format: Submit your paper in Microsoft Word (.doc or .docx) and PDF format.
- Review Process: All submissions will undergo a double-blind peer-review process. Authors will receive feedback and may be required to make revisions.
